## Commander's Message

PROPOSE REDUCTION TO VETERANS BENEFIT

"An ounce of prevention is worth a pound of cure." With all the commonsense sayings, nothing is so rewarding as having oneself experience the pains of disbelief!

The Congressional Budget Office (CBO) has suggested several substantial reductions to veterans' benefits.

1: Reduce VA's Disability Benefits for Veterans Who Are Older Than the Full Retirement Age for Social Security: https://www.cbo.gov/budget-options/60917

Veterans with medical conditions or injuries that occurred or worsened during active-duty service receive disability compensation from the Department of Veterans Affairs (VA). By law, VA's disability ratings (the basis for disability payments) depend, as far as practicable, on the average earnings that veterans would be expected to lose given the severity of their service-connected medical conditions or injuries. Those ratings do not depend on whether a particular veteran's conditions reduce the person's earnings. Veterans who work are eligible for benefits, and most working-age veterans who receive such compensation are employed. After veterans reach Social Security's full retirement age, VA's disability payments continue at the same level. (Social Security's full retirement age is 67 for people born after 1959.) By contrast, the income that people receive from Social Security or private pensions after they retire usually is less than their earnings from wages and salary before retirement.

Under this option, veterans who start receiving disability compensation payments in 2026 or later would have those payments reduced by 30 percent at age 67. Social Security and pension benefits would be unaffected by this option. Veterans who are already collecting disability compensation would see no reduction in their VA disability benefits when they reach age 67.

2: End VA's Individual Unemployability Payments to Disabled Veterans at the Full Retirement Age for Social Security: https://www.cbo.gov/budget-options/60916

The Department of Veterans Affairs (VA) provides disability compensation to veterans with medical conditions or injuries that were incurred or worsened during active-duty service. The amount of compensation depends on the severity of their disabilities (which are rated between zero and 100 percent) and other factors. In addition, VA may increase certain veterans' disability compensation to the 100 percent level even though the department has not rated their service-connected disabilities at that level. To receive the resulting supplemental compensation, termed Individual Unemployability (IU) or (TDIU) payments, disabled veterans must apply for the benefit and meet two criteria. First, they generally must have a disability rating

## Legislative Update

Claim Shark Bill Dies in the House

SB 1222 (Reeves-R) heard in committee on February 11 was referred from the Labor and Commerce Committee to the Rules Committee by voice vote, effectively killing the bill for this legislative session. The Veterans Service Organizations (VSOs) were successful in stopping legislation that would have permitted their predatory practices to continue.

After passing the Senate (36-3) the bill crossed over to the House, and due to the efforts of the VFW and other VSOs failed to gain support. This leaves the Claim Shark issue unresolved for this legislative session. Many thanks to everyone who contacted their delegates. It made a difference.

In the 2026 legislative session the issue of banning claim sharks in Virginia will be revisited. We will be working to build a coalition for next year and will be updating the position paper for the Joint Leadership Council of VSOs. We will be working to educate Virginia legislators on the harmful effects to veterans if Claim Sharks are not banned in Virginia.

We are also working with the VFW National Legislative Office to work on amending Title 38 of the US Code, which if enacted could negate the myriad variations of individual state laws.

# VFW Reminds Members to Stay Focused Amid Confusion in the Capital

WASHINGTON (Feb. 14, 2025) — Over the past few weeks, I, like many of you, have been inundated daily with news from our nation's capital about the current administration's new way of doing business. Between the reports of mass employee lay-offs, funding freezes, program cuts, and agency restructures across the entire government, it is hard to know exactly what to sound the alarm about. Upfront, I want to tell you the Veterans of Foreign Wars (VFW) know our members and other veterans are concerned. We've received a multitude of calls and emails from veterans worried about what's happening with federal benefit programs and the federal workforce, to include 1,000 VA probationary employees who were let go yesterday. They've asked if their VA benefits will be cut, or healthcare and services be diminished because of the confusion in Washington D.C.

Make no mistake, the staff at the VFW Washington Office is working hard behind the scenes to protect you and ensure you receive the care and benefits you have earned. When the hiring freeze was announced earlier this month, the VFW intervened to make sure that critical VA positions were left alone. When the funding freeze was announced, VFW worked around the clock to ensure the Office of Management and Budget maintained all 44 critical VA programs. When the federal buyout and reductions in force were announced, we insisted that VA communicate which critical positions would be exempt. Each step of the way, we have received the answers we've needed. VA payments for disability and education went out on time. Hiring for critical positions resumed, and more than 43,000 VA employees were exempted and retained in critical care and benefit delivery positions.

In December, we put our stake in the ground, insisting that leaders "Honor the Contract" for veterans' benefits. In his confirmation hearing, Secretary Collins refuted the notion that veterans would be means tested to receive their earned disability. He reiterated this point in a public statement earlier this week. VFW is going to hold him to this. We will make sure that Secretary Collins "Honors the Contract."

We know there is a lot of uncertainty for veterans today. For those of us that have seen combat, we know not to be concerned with every explosion that happens on the battlefield. Not every round flying overhead is aimed at us. That is why we must not get distracted and stay focused on the mission, push towards the objective and when necessary, be ready to react to contact.

Rest assured, my staff and I will continue to be vigilant, ensure that veterans' personal information is protected and VA provides the care and benefits veterans have earned. We are watching your six. I want to thank the VFW members and veterans who have reached out to us so far, and I want to encourage you to keep it up. This is how we work together to make sure that our nation "Honors the Contract" to care for our veterans.

### VA-2025-XX PROPOSED AMENDMENT TO NATIONAL BY-LAWS MANUAL OF PROCEDURE

ARTICLE II – POSTS, Sec. 218 – Officers and Chairmen, Duties and Obligations, (6) Adjutant, (d.)(1.) A copy of the original application of every member admitted to the Post.

Change the wording and requirement of this item to read as follows:

(d.)(1.) A copy of an original application for membership shall be kept until that record is successfully processed into the VFW National Database (e.g. OMS), at which time the original application may be kept as a historical record to the Post for Membership. The National Database will be the **record of authority on membership.** 

#### Reasoning for Change:

Membership is not recognized unless the Application for a prospective member has been transmitted to and accepted by VFW National. While OMS is the current online system, it may not always be so and is noted as an example so this change will have longevity within the Manual of Procedure.

Many posts have membership that dates back decades and some posts are quite large requiring the maintenance of in some cases hundreds and thousands of records that have been entered electronically in the VFW National Database already creating a system of duplication.

Not all posts maintain electronic or digital copies of membership forms or have that ability. Posts also do not keep copies of member DD214 or eligibility documents past the point of verifying eligibility unless that member becomes an officer within the VFW per Sec 218 (a)(6)(d)(5). This in turn denotes a series of duplication where VFW National is already the record of authority for membership.

Posts are not notified of transfers and changes to membership. The Adjutant does not have a reasonable expectation to track these changes as that appointed officer and does not have access to reports only provided to the Quartermaster from the VFW National Database.

The VFW National Database should be kept as the record of authority for all membership once an application has been received by the Post and properly transmitted to VFW National and entered into the VFW National Database. It is not intended by this change that the VFW National Database maintains eligibility information for those members and if needed the Post will work with the member or family to provide assistance for this data. At that time the original application processed by VFW National and the member is accepted, the post may keep the application as a historical record.

# VFW Calls on Administration, Congress to Stop Indiscriminate Firing of Veterans

WASHINGTON (Feb. 24, 2025) —Ten days ago, I shared the Veterans of Foreign Wars' (VFW) concerns for the news of mass lay-offs coming out of our nation's capital. Since then, it has become clearer that the veteran community has been hit hard as probationary federal jobs are being axed across the country, to include the latest announcement of 1,400 more just let go from the VA.

With veterans making up approximately 30% of the more than 2.2 million employed by the federal government, the potential of losing thousands of veterans from the government work force is troubling. A lot of these aren't brand-new, off-the-street employees. These are employees who have been serving the American people for years, in uniform and in civil service, and at least some of whom have been or are being caught by a formality in administrative statuses. There are bigger ramifications in firing veterans than just faceless workers being let go. The American people are losing technical expertise, training and security clearances already bought and paid for by taxpayers. These veterans are now being told their skills are no longer useful to the government. We're losing people who are genuinely committed to the mission and find a continued sense of purpose in what they do. On top of all this, studies show having gainful employment is a social determinate of health and gets ahead of arguably one of the root causes of veteran suicide. Since the federal government is the


single largest employer of veterans in the nation, it's veterans who are being indiscriminately harmed in this bull-"DOGE"-ing of the federal work force.

I was wounded in combat during the Vietnam War. I am thankful that the medics who treated me chose not to take my whole arm for the sake of efficiency. It took a trained eye, a skillful hand and human intuition to fix me up and get me back in the fight. In my experience, those operating with a scalpel have a better chance at saving limbs than those who operate with a chainsaw.

Unfortunately, it appears humans have been taken out of what is a human capital issue. It has been reported to us from veterans who have lost their jobs that the emails they received letting them go were disjointed, and inconsistent across the board. This leads us to believe they were automated with little to no oversight or thought. When it comes to complex problems, we rely on humans to make the right choices at the right times. We should never leave the hard decisions that impact people's lives and livelihoods to an algorithm or an email distribution list. On Tuesday, March 4th, I will testify before a joint session of the congressional veterans' affairs committees to deliver the VFW's priorities and call on Congress and this administration to put an end to the indiscriminate firing of veterans in the government workforce. I am also calling on VFW members to "march forth" and join me on that day. I want to see hats in the hallways of our Capitol as our legislative committee members engage with lawmakers in demanding that they "Honor the Contract" the government made with those who have already served and sacrificed so much for America and their fellow Americans. It's time to apply pressure and stop the bleeding.

between 60 percent and 90 percent. Second, VA must determine that the veterans cannot maintain "substantial gainful employment" because of the severity of a service-connected disability. Receipt of IU is not based on age, voluntary withdrawal from work, or other factors.

This option consists of two alternatives. Under the first, VA would stop making IU payments to veterans age 67 or older (the full retirement age for Social Security benefits for those born after 1959). That restriction would apply to both current and prospective recipients. When veterans reached age 67, all VA disability payments would revert to the amount associated with the rated disability level; veterans age 67 or older who were already receiving IU payments would no longer receive them after the effective date of the option. Under the second alternative, veterans who began receiving the IU supplement after December 2025 would no longer receive those payments once they reached age 67, and no new applicants age 67 or older would be eligible for IU benefits after that date. Veterans currently receiving IU payments who would reach age 67 or older after the effective date of the option would continue to collect the IU supplement.

3: Introduce Means-Testing for Eligibility for VA's Disability Compensation: https://www.cbo.gov/budget-options/60....

Veterans with medical conditions or injuries that occurred or worsened during active-duty service may receive disability compensation from the Department of Veterans Affairs (VA). Payments are structured differently than other disability programs. VA's disability payments are intended to compensate for the average earnings that veterans would be expected to lose given the severity of their service-connected medical conditions or injuries, whether or not a particular veteran's condition reduced his or her earnings. Unlike disability programs such as Social Security Disability Insurance, payments are unaffected by a veteran's earnings or other types of income.

Under this option, VA would means-test (that is, restrict full compensation to those with income below a certain amount) all current and prospective recipients of VA's disability compensation. Beginning in January 2026, veterans with service-related disabilities and total household income below \$135,000, excluding disability income from the VA, would receive full benefits. That threshold corresponds to the 70th percentile of total household income in the United States in 2022, adjusted for inflation to reach the threshold value applicable to 2026 benefits. CBO estimates that nearly 30 percent of veterans receiving disability payments from VA will have household income above that threshold in 2026. (After 2026, that income threshold would rise with the consumer price index for urban wage earners and clerical work-

ers.) Above the threshold, benefits would be phased out at a constant rate: For every additional two dollars of gross household income, disability compensation would decrease by one dollar.

4:Narrow Eligibility for VA's Disability Compensation by Excluding Veterans With Low Disability Ratings: https://www.cbo.gov/budget-options/60...

Veterans with medical conditions or injuries that occurred or worsened during active-duty service may receive disability compensation from the Department of Veterans Affairs (VA). The amount of compensation depends on the severity of their disabilities (which are rated between zero and 100 percent) and other factors. By law, VA's disability ratings (the basis for disability payments) are to be based, as far as practicable, on the average earnings that veterans would be expected to lose given the severity of their service-connected medical conditions or injuries. Those ratings do not depend on whether a particular veteran's conditions reduce his or her earnings.

Under this option's first alternative, VA would narrow eligibility for disability compensation by requiring a disability rating of 30 percent or higher for all veterans; as a result, some current recipients would no longer receive benefits. The second alternative would require a 30 percent or higher disability rating only for new disability compensation applicants. (Current recipients would not be affected.) CBO estimates that in 2026, about 20 percent of veterans will have a disability rating below 30 percent.

5: Include VA's Disability Payments in Taxable Income: https://www.cbo.gov/budget-options/60947

The Department of Veterans Affairs (VA) provides disability compensation to veterans with medical conditions or injuries that occurred or worsened during active-duty service. By law, VA's disability ratings (the basis for disability payments) are to be based, as far as practicable, on the average earnings that veterans would be expected to lose given the severity of their service-connected medical conditions or injuries. Those ratings do not depend on whether a particular veteran's conditions reduce that person's earnings. Disability compensation is not means-tested (that is, restricted to those with income below a certain amount), and payments are exempt from income taxes. Payments are in the form of monthly annuities and typically continue until the beneficiary's death.

This option would include VA's disability benefit payments in taxable income.

## Legislative Effort for 2026

Thanks to Brianna Sewell's efforts we able to stop legislation that would have permitted claim sharks to operate in Virginia.

Fully expecting the issue to resurface in the 2026 legislative session we have begun building a network of legislators who will support out position. At this kick-off session we were able to meet with many of them and explain how claim sharks are exploiting our veterans. We are apolitical and will do what it takes to reach out across both aisles.

## "Friends of the VFW" [Not]

Commanders and Comrades,

Every couple of years we get notified of groups calling themselves 'Friends of the VFW" who do not have any official or legal ties as they are just a group of friends that care. Along with this we also get statements that someone from National said it was legal yet that person from National is never identified. Here is what I will put in writing when it comes to the use of the "Friends of the VFW" as a loosely formed group or other groups with similar sounding names.

The main problem with these loosely associated organizations or groups is they falsely portray themselves as being officially associated with the VFW when they're not. The underlined portion of 803 [of the National Bylaws] really hits this sentiment home and I think it's important for these affiliated Posts to know these unsanctioned activities are in violation of the National Bylaws and as such are subject to corrective action by higher authority, namely the Department.

Pursuant to Section 709 of the National Bylaws, "Any activity, clubroom, holding company or unit sponsored, conducted or operated by, for or in behalf of a Post, County Council, District or Department shall be at all times under the direct control of such Post, County Council, District or Department and all funds derived there from shall be at all times under the direct control of such Post, County Council, District or Department."

709 continues, "All money, property or assets of any kind or nature, as well as all books and records, owned, held or used by any activity, clubroom, holding company or unit sponsored, conducted or operated by, for or in behalf of a Post, County Council, District or Department shall be the property of such Post, County Council, District or Department and must be placed in the care and custody of the respective Quartermaster. Such money, property, assets, books and records shall be subject to the same rules and under the same procedure as any other Post, County Council, District or Department money, property, assets, books and records."

I think all of the Section 803 of the National Bylaws is important here, but specifically "No member or other person shall use or wear any seal, emblem, badge, insignia or uniform of the Veterans of Foreign Wars of the United States while engaged in any commercial or political activity in such a manner as likely to falsely convey that such activity is approved or endorsed by the Veterans of Foreign Wars of the United States."

In that same vein, Section 805 states, "No person shall use any name mentioned and described in Section 804, or any other trade name, trademark, service mark and/or membership mark of this Organization in connection with any financial, commercial or other business activity without the express written authorization of the Ouartermaster General of the Veterans of Foreign Wars of the United States."

Please distribute to all levels and leaders in your respective Departments.

Any questions please let me know as I am just itching to know how your State Laws make it legal in your state.
