Our scouts have had a fun and educational summer this year. They are back in school now and they are also starting up the new scout year at the same time. In September they will start up their formal scout meetings again. Over the summer meetings are not held as often and they normally have some fun activities or are planning for future activities. This gives families a chance to relax and go on vacations without having to worry about missing out on scouting activities.

This summer started out with their summer camp week at the Goshen Scout Reservation. I heard that the scouts did great and earned lots of merit badges, many of which are normally only earned at summer camps. These include the different shooting badges, water rescue and different boating type badges.

The scouts also performed cleaning of their adopted road which they do every quarter. The road is Signal View Dr. They have been cleaning this road for a number of years now and have removed tons of garbage over the years. This is a great community service project for them as this road runs alongside the Signal Hill Park that a lot of families with young kids frequent. Their service creates a safer place for the youth and families.

The scouts are currently planning their Labor Day beach camping trip. They have done this for a few years now and it is a great way for the scouts to end the summer. We also had an Eagle Scout COH this summer for one of our scouts. This is the scout whose project was rebuilding and painting the fencing at a horse rescue outside Fredericksburg.

Our scouts are also taking inventory of their trailer. They are performing maintenance on the trailer itself as well as replacing/fixing any of the gear in the trailer that needs attention. One of the troops positions is quartermaster and they are the ones responsible for the various assets.

Our cubs participated in the National Night Out this year and invited the Troop to participate with them. Here they basically set up a recruitment table and had some success with interest from multiple families. Post approves commemorative bench for Rose Hill Cemetery

"Rose Hill Cemetery is tucked away in an industrial area today, but when it was established in 1887, this was a rural area on the outskirts of Manassas.

Created at a time when local ordinance segregated burying grounds by race, this was one of the cemeteries in Prince William County that exclusively served the Black community. The Rose Hill Cemetery Association, run by members of the African American community, was the early steward of this cemetery.

Like other African American cemeteries of the time, Rose Hill received no public support from the White community or local government. Care and maintenance, including the opening and closing of graves for funerals, were provided by members of the Black community. The first burials likely included men and women who were born enslaved.

In 1978, after nearly a century of operating privately, the Cemetery Trustees approached the City of Manassas about taking over Rose Hill. After two years of negotiations, an agreement was reached in 1980, and the City accepted ownership.

Today, Rose Hill is closed to new burials, but the cemetery remains an important connection to the people who helped make Manassas what it is today."*

Many veterans are interred at Rose Hill, some dating back to the Civil War. Attempts to identify all of the graves have been mixed at best and many remain unmarked. This year, as part of Memorial Day and Veterans Day ceremonies VFW Post 7589's Scouts began placing flags at veteran graves that have been identified.

To recognize all of the veterans buried there Post 7589 and American Legion Post 10 agreed that a commemorative bench should be placed in a prominent location. Klien Memorials of Manassas will construct and install the bench, the cost of which will be shared equally with Post 10.

The following text, bordered by VFW and American Legion medallions will be inscribed on the bench:



IN MEMORY OF THE UNKNOWN RESTING HERE WHO SERVED IN UNITED STATES ARMED FORCES AND ARE KNOWN BUT TO GOD



Contracts were signed on August 20 with delivery anticipated for early November, hopefully in time for Veterans Day. We plan to have an unveiling and will invite dignitaries from the community.

VFW Approves ball caps in meetings

At the 126th National Convention the membership approved a change to the by-laws to allow ball caps to be worn at official meetings.

Members may wear ball caps but officer are not permitted to wear them in official meetings.

The following message was sent to Department Commanders:

In response to several requests for information through social media channels, attached is a mock up of what the recently approved official alternative cap will look like. It will have all the essential components of the official overseas cap, and the color of the sandwich bill will denote the type of unit (Post-Yellow, District-Green, Department-Red, National-Silver/Grey). We are currently considering options for a unique identifier to help prevent pirating.

A couple pieces of information. First, don't expect to see these on the VFW Store site for purchase until beginning of December at the earliest. Delivery to the consumer will be four to six weeks from order. The only title options will be what's available on the item drop down. It's difficult enough to get some specialized titles on the overseas caps and there is even less space for that on these ball caps. To help mitigate incorrect assumptions or prevent rumors, please send any questions that reach you to me for clarification. Thanks!



Past Commander In-Chief

The 126th VFW National Convention was historic on a number of levels. Confirming our support of the Senior Vice Commander in Chief was nominated and elected to be the first, as she described, VFW Commander in Chief wearing a dress. As CIC Carol Whitmore declared, she will certainly not be the last. Having worked with this individual as she went though her year as the designate, to her election and installation as Junior Vice Commander in Chief, Senior Vice Commander in Chief, culminating with her election at the 126th National Convention. Chief Whitmore has my full support as she serves ALL members of the Veterans of Foreign Wars and its Auxiliaries.

In completing my term as Commander in Chief we stood together to ensure the principles of our founding be returned to those with whom it has been placed 126 years ago...the delegates to the National Convention. I ask you to embrace and operate with the courage of your convictions as you abide by the Bylaws, Manual of Procedures, and Ritual adopted by the delegates on the floor of the convention. Three years ago I gave you a reminder that our tired and outdated methods were not our future. "But we've always done it this way" was overtaken by innovation and changes in our world. This was a great step forward. But a shift was allowed to usurp the will of the most important member in our organization, the individual member through their elected delegates to the National Convention. Over these last theee years I consistently declared this must cease. Over time many of those who have served at the highest levels of this organization have attempted to absconded with your rights found in our Charter and Bylaws. At the 125th National Convention in Louisville KY you elected me to the high office of Commander in Chief of the Veterans of Foreign Wars of the United States of America. With my election and installation you demanded I lead and I said lead I

At this convention I brought a new badge to bring to your attention an end a destructive practice if allowed to continue will take away the voice of the member. A select few in each of the conferences have been allowed to make the choice FOR YOU and not with you. The system that was adopted many years ago was created to SELECT a candidate at the Junior Vice Commander in Chief for the delegates at the National Convention to consider. But over time the system has been corrupted. The badge I created to bring your focus to what has happened said "Let's Make A Deal" with a slash meaning this practice must stop. In addition there were two phrases that pointed to the change to be applied throughout our entire organization. No more behind the curtain and No more closed door conspiracies.

While there are some who suggest there was some sort of conspiracy when the Junior Vice Commander in Chief became a contested election with an individual stepped forward from the floor. LET ME BE CLEAR. AS CIC I was made aware of the possibility by the Adjutant General on Friday morning Aug 8 with the Junior Vice Commander in Chief at the meeting. In accordance with our National Bylaws and Manual of Procedure a candidate from the floor is permitted. Push back was applied to stop this authorized action and I FIRMLY DECLARED THIS TO BE AUTHORIZED and I would not intervene to this member's right.

Here is where it gets provocative. Rumors, innuendoes, accusations of impropriety spread throughout the attendees. I have preached having the courage of your convictions. There are questions by some of why did this happen? HERE IS MY RESPONSE. Our process to be elected and installed at any level has not changed. Election to an office is not a given. One must be elected. If one is unsure of support one should campaign. Arrogance is not a desirable character trait. With a probable contested race committee meetings continued.

As then Commander in Chief I have encouraged, authorized investigations and acted upon complaints that were signed. There have been serious accusations by a number of individuals and I am certain Commander in Chief Whitmore will abide by the tenants of her office. BUT THAT BEING SAID, AN UNSIGNED/DOCUMENTED COMPLAINT IS NOT A COMPLAINT THAT CAN BE ACTED UPON.

Do not let those who seek to intimidate, threaten, or coerce you in any way STOP YOU. Have the courage of your convictions if not for yourself for those potential victims who will suffer because you stayed silent. Let remove these who commit such actions from our rolls.

BELIEVE IN WHAT YOU DO - DO WHAT YOU BELIEVE IN.

Important message from VFW Adjutant General.

I have been informed of accusations raised during the Women Veterans Committee at our National Convention last week. Concerns were raised about harassment and bullying by those in leadership. Let me be clear—whether that harassment is verbal or physical in nature—this behavior is unacceptable and has no place here or in the VFW. Chief Whitmore and I have formally initiated an investigation. To ensure this process is handled thoroughly and with integrity, we are now in the process of collecting statements from those who may have witnessed or experienced incidents related to these concerns.

I know personally how damaging and painful these experiences can be. I want you to hear directly from me that your safety, dignity, and well-being matter above all else. If you have experienced or witnessed harassment, please know you will be heard, supported, and protected from retaliation.

If you, or someone you know, have information relevant to these matters, I strongly encourage you to provide a written statement. These statements are essential in determining the facts and allowing us to move forward appropriately. Please understand that this investigation can only proceed based on the information submitted, and your cooperation is vital to achieving a fair and just outcome.

All statements will be treated with the utmost seriousness, confidentiality, and respect. I urge anyone with knowledge of relevant events to come forward so that we may address these matters with the accountability and professionalism they deserve.

Virginia Attorney General is suing the Department of Veterans Affairs

AG Miyares sues VA over denial of veterans' education benefits

RICHMOND, Va. (WVIR) - Virginia Attorney General Jason Miyares is suing the Department of Veterans Affairs (VA), alleging it has failed to comply with a U.S. Supreme Court ruling guaranteeing full education benefits to veterans.

The suit, filed Thursday, August 14, in the Court of Appeals for the Federal Circuit, names the Veterans of Foreign Wars (VFW) and the Iraq and Afghanistan Veterans of America as coplaintiffs.

Several individual veterans, including James Rudisill—the decorated Richmond Army veteran whose case went to the Supreme Court—are also joining the lawsuit.

"Veterans who qualify for benefits should receive their full benefits—full stop," said Miyares. "The U.S. Supreme Court ruled that veterans eligible for the Montgomery and Post-9/11 G.I. Bills are entitled to full benefits, not partial. We are confident in our case and look forward to an amicable resolution on behalf of those who have served."

The legal action follows Virginia-led efforts in 2023, when Miyares organized two multi-state coalitions urging the Supreme Court to hear and uphold Rudisill's claim.

In 2024, the court ruled in his favor, guaranteeing eligible veterans a combined 48 months of education benefits.

Despite the ruling, the VA has continued to deny full benefits to many veterans, due to what Miyares believes is a narrow interpretation of the GI Bills.

The attorney general highlighted one Virginia Army veteran who served more than 20 years overseas but was denied full benefits, preventing him from transferring funds to his daughter for law school.

Earlier this year, Miyares again led bipartisan coalitions supporting the veteran's claim. Last month, the VA agreed in principle to restore his benefits but did not extend the resolution to other affected veterans.

Miyares is now asking the appeals court to enforce the Supreme Court's decision and ensure the VA provides full benefits to all eligible veterans.


